Voting concerns from Leroy Beyal about the voting polls where no one is available to interpret and to be helpful for the elders and also the workers were not kind or helpful when ask a question about the questions presented on the Ballot. He did go into to vote and only voted on some but could not on some so we need these workers to explain and to help the voters who can not read or hear.

Leroy Beyal has a concern also on the ballot box for our Chapter it needs to fix it looks easily can be broken into so he would like for it to be fixed.

Recapped on our Vice President she did entertain the question presented by Mrs. Joe on the resolution that was voted on and did it get forward and she did answer Mrs. Shirleen Joe on the resolution sent to the McKinley County.

VP- She is also concern on the Budget process on how we can't meet in person its usually done on the phone and we also need to work together.

Mr. Rodriguez made a point of order cease all conversation.

Ms. Grace Silversmith is also requesting on her culvert when is it going to be installed its been awhile even months and still waiting they did NDOT did install one but in a different area also the same on Lois Becenti's Road as well. Picture was sent to the President.

Elouise Clemments also needed her culvert in the Hard Ground Flats she had a resolution passed in the summer and she too is waiting. VP question we had set a budget to purchase some culverts when will that be purchased.

Rodriquez is concern on these issues that were sent to the Administration, instead of us always asking the PEP worker when it should be the CSC, so he recommended to write a memorandum on who and why these are not address properly and in a timely fashion.
