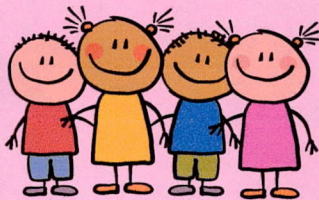
PROVIDE THE FOLLOWING DOCUMENTS TO DETERMINE YOUR ELIGIBILITY AT TIME OF
APPOINTMENT/ WALK-IN OR YOU MAY EMAIL DOCUMENTS

- INCOME VERIFICATION
- LAST 2 CHECK STUBS (30 DAYS)
- PUBLIC ASSISTANCE VERIFICATION (SNAP, TANF, WORKFORCE ETC)
- FAMILY SOCIAL SECURITY CARDS
- CHILD(REN) BIRTH CERTIFICATE
- FAMILY CERTIFICATE OF INDIAN BLOOD
- PARENTS DRIVERS LICENSE/PHOTO ID
- CHILD(REN) UPDATED IMMUNIZATION RECORD (30 DAYS)
- SCHOOL VERIFICATION, IF A STUDENT (INCLUDES ONLINE COURSES)

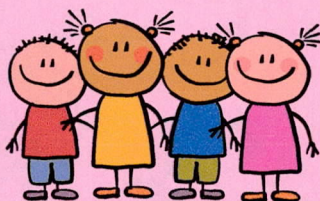
