Ansley Curley introduce himself and announce that he was selected as an LDA for Council Delegate Nathan Notah. He said, he wants to make sure projects are processed in a timely manner, with this as a priority, he is sent to Coyote Canyon Chapter and ask what the needs are for the Chapter. He is requesting for all project that is funded by State of NM, current ICIP list, other priority project list,

Other funding to Coyote Canyon Chapter with project name, cost, timeline, project description, include ARPA Chapter allocation, all assessment collected if available, projects submitted for funding. Mr. Curley checked with Chief of Projects in Window Rock and their office have not received any projects from Coyote Canyon Chapter. Council Delegate Notah is aware of this information.

Mr. Curley mentioned Council Delegate Notah met with former CD, Halona and Ansley don't know what was discussed. He is aware that the cemetery has not moved forward as of today.

Leroy Beyal asked if there is a backup project if the funds for cemetery is not used.

NM funds for cemetery will be returned to the State if not used by the expiration date.

Ansley Curley states, CD Notah & himself are talking about setting up a website for District 14, we will be able to see all the chapter updates, newsletters.

Chavez John thanked Ansley Curley for being present at our CLUPC meeting. Chavez mentioned he worked 38 years with Navajo Nation and is familiar with The process of documents from chapters to Window Rock offices.

Coyote Canyon should be receiving approximately 1.7 million and would be used for Greater, vehicle, scholarship, housing renovation, roads, PEP.

The question here is "should we have something that will last"? Will need to submit (4) four proposals, water line extension for 100 families, chapter parking lot, environmental clearance, archaeological clearance. I want to do the right projects that will last a long time.

Chavez John mentions to Mr. Curley, CLUPC is responsible for projects and chapter officials responsible for implementation. Our Land Use is certified in 2006 and was told our chapter is not certified, needs recertification.

Evelyn Morris congratulates Ansley Curley.

Coyote Canyon chapter needs a lot of help. Reaffirm to hire the accounting clerk and CSC position. We are back at square one, there is no record keeping and there is a gap between the chapter officials and administration. The waterline is pretty much in process. We really need the community members to put in their input as to how to utilize the fundings received. We really need to work as a team and help us fill the positions at Coyote Canyon Chapter. really brought chapter back up from October 2021 to November 2022.


Dianna – has not communicated with MC Baldwin, she will start to contact MC again will update next CLUPC meeting.


